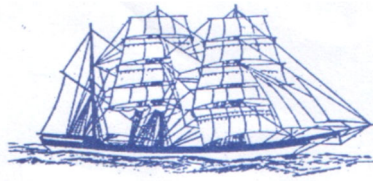


# CYNGOR TREF PORTHMADOG



## PROPERTY AND DEVELOPMENT COMMITTEE SPECIAL MEETING MINUTES

**1. To decide on Gwynedd Council's request for the Town Council to take ownership and responsibility for Howard Bowcott's sculptures.**

**Decision:-** the Clerk to check with the insurance company; ask Iwan G. Evans C.G. why the Town Council needs to insure them as they are on Gwynedd Council land; why it is necessary to insure 3 and not 4 and to ensure receiving a written response from him by 23.10.24 before considering signing the agreement.

The plans were studied in detail in order to propose corrections and changes. <b>Decision:-</b> the Clerk to rewrite the information / corrections in table form to be checked by the Chairman before sending it back by 25.10.24.
3	<b>HUW OWEN 15.10.24</b>	<b>Breuddwydion Bro</b> Following receiving an email from Angharad ap Iorwerth (which was included in the correspondence and discussed at the full meeting 8.10.24) regarding this proposed plan, Huw Owen asked what the Town Council's decision had been on the matter. <b>Decision:-</b> to send the same answer to Huw Owen and to Angharad ap Iorwerth reporting that the Town Council will consult with Haydn Jones, Chief Community Officer C.G., to ask if it would be possible to combine or modify the Breuddwydion Bro project with the ideas for Menter Madog.
