14.5.24. CONSTITUTIONAL AND STAFF MATTERS

Update on the Clerk's position

The Clerk explained that the Council had advertised the position of Clerk twice and had failed to get anyone to undertake the duties. The Council has asked the former Clerk, Marian Roberts, to return to the post for two months and she has agreed to continue in the post. Regarding having to advertise the position once more - the Clerk had received legal advice from Mel ab Owain of One Llais Cymru and he has confirmed that there is no need to advertise once more as Marian Roberts is willing to continue in the position.

The Clerk left the meeting while the Councillors came to a decision.

The Clerk returned to the meeting in order to record the Council's **decision** that they were satisfied that she should continue in the post.

MATTERS ARISING:-

The Vice-Chairman, Cllr John Gwynedd Roberts, took the chair to preside over the meeting during discussions on the Chairman Cllr Aled Griffith's proposals.

15.5.24 Cllr Aled Griffith - motion to complain about bus parking spaces that have stolen car parking spaces at the Healthy Living Centre, Glaslyn.

DECISION:- before taking further action, the Clerk to check if a similar complaint had been made in the last 6 months.

16.5.24 Cllr Aled Griffith - motion to decide on a way to congratulate Medi Harris on her success in being selected for the Olympic swimming team.

It was heard that there was an intention to give an award from Bill Swann's work to Medi Harris when she was chosen to represent Wales in the Commonwealth Games but this was not acted upon. It was agreed that she should be congratulated by giving her a gift for her achievement in reaching the Olympic Swimming Team. **DECISION:**- the Clerk to re-examine the details of the original enquiry about artwork by Bill Swann and to share information with the Council in order to choose an appropriate piece, according to the proposal of Cllr Sandra Bodden Jones, Cllr Michael Roberts seconding. It was also decided to write her a letter congratulating her and to wish her every success in the Olympic Games as proposed by Cllr Dr Melfyn Edwards, Cllr Alwyn Gruffydd seconding.

The Chairman returned to chair the meeting.

7.5.24 Cllr Dr Melfyn Edwards - proposal to request an update on the situation of Cors Borth y Gest.

It was heard that rubbish and construction waste continued to be carried to Gors Borth y Gest despite the previous concerns that the Town Council had referred on to relevant agencies.

DECISION:- to act on the proposal of Cllr Dr Melfyn Edwards by sending a letter expressing the concerns of the Town Council to the Chief Executive of Gwynedd Council; Head of Gwynedd Council's Enforcement Department and to Liz Saville Roberts, Cllr Gwilym Jones seconding.

18.5.24 Cllr Dr Melfyn Edwards - motion to decide on the Town Council's contribution to the 2024 Christmas celebrations(see Correspondence 13, R.J.Electrics' second quote)

There was a long discussion regarding the costs of Christmas lights. It was noted that the Town Council would spend around £12,000 this year on buying 12 new lights on the street lamps; repair existing lighting; new lights on one of the Park's outer trees as well as the costs of the Christmas trees; paying Gwynedd staff for installing and removing the trees; paying a local electrician for installing and removing the lights on the Christmas trees

and R.J.Electrics electricians' costs for installing, removing and checking all the lights. It was heard that the Town Council's annual Christmas expenditure was usually around £14,000.00.

It was noted that other Christmas events took place around the same time as the council's celebration last year and it was agreed that there should be better collaboration in order to organise one big joint event for this year.

DECISION:- to go ahead and spend the £12,000 on new lighting as proposed by Cllr Gwilym Jones, Cllr Michael Roberts seconding.

DECISION:- to enquire if there are other events planned this year before arranging to work together with the other organisers in order to hold one big joint event according to the proposal of Cllr Sandra Bodden Jones, Cllr Carol Hayes seconding.

19.5.24 Cllr Alwyn Gruffydd - proposal to complain about English-only parking fines from the company that manages the parking system in Y Canolfan.
