There was an update on the following :-

• Cae Bodawen's new gate - G.L.Jones will provide a red gate and galvanized railings.

• Presentation of a donation to **Medi Harris** took place on 16.8.24 and was a successful evening.

• Cae Pawb – open day on 17.8.24 was a success and collected over £500 to share with good causes.

• National Grid – Cae Bodawen – a site meeting was held on 28.8.24 and it was noted that the excavation work was due to start in September 2025 and finish by 2028. It was noted that the Clerk had received an email from Nat. Grid requesting a list and prices of new play equipment for Cae Bodawen by 26.9.24. It was suggested that a special meeting of the Property Sub-Committee should be held to discuss the matter in order to respond within the time limit.

• There was a meeting with Menter Bro Ffestiniog officers on 6.9.24 and Gwynedd Council's Community Officer, Haydn Jones, to discuss the way forward regarding the development of the Ganolfan as a business enterprise (**Menter Madog**). Haydn Jones will meet with the Ganolfan's committee members to discuss further.

# 91.9.24 Elect a representative on Ysgol y Gorlan's Board of Governors

It was noted that many of the Councillors had already been on the Governing board therefore **Decision :-** to leave the matter until the October meeting.

The Clerk noted that the Head of Ysgol Eifion Wyn had been in touch asking for a representative on their Governing Board following the resignation of Cllr Llywelyn Rhys as the representative of the Town Council.

**Decision:-** Cllr Karena Owens agreed to represent the Town Council and the Clerk will inform the school of Cllr Owens' contact details.

Cllr Llywelyn Rhys raised a point of order stating his displeasure that the Clerk had refused to include 2 proposals from him on the agenda of tonight's meeting. The Clerk explained that she had responded to the request by stating her reasons for her decision.

**Decision**:- to amend the proposals and include them on the 8.10.24 agenda according to Cllr Alwyn Gruffydd's proposal.

### 94.9.24 Cllr Llywelyn Rhys - Proposal to make an application to Gwynedd Council to implement a contingency plan to open Lôn Gwydryn access when traffic to Black Rock beach becomes excessive.

Cllr Gwilym Jones listed some of the reasons why Gwynedd Council is not willing to use Lôn Gwydryn as follows:-

- The residents of Lôn Gwydryn are not satisfied
- · Gwynedd Council wants to keep one emergency access to the beach
- Not enough staff
- Lôn Gwydryn entrance sand is too soft for cars to use
- One way system not working

We also heard about the general difficulties of using Treflys road, Morfa Bychan and the regular congestion in Bank Place.

**Decision:-** amend the proposal to "Propose asking Gwynedd Council to re-examine the Morfa Bychan beach, Treflys and Bank Place transport system at busy times of the year" according to the proposal of Cllr Llywelyn Rhys, Cllr Carol Hayes seconding.
