C4. 1.25 Christmas expenditure

Investigate the possibility of changing the arrangements for Christmas 2025

The Clerk had prepared a detailed breakdown of the Christmas expenditure for 2024 and was very concerned that it was all going to cost **almost £29,500** - which is **almost half of the annual Precept of £66,962.10**. The fact that Gwynedd Council's bill of £2,367.26 on 9.4.24 for erecting and removing Christmas trees in 2023 was included in the 2024 budget and the added expense of £12,799.44 for 12 new lights in 2024 meant a significant increase to the normal annual costs.

She had researched the Christmas provision of other nearby towns:-Pwllheli – \pounds 100,000 for a 5 year contract with the Lite company Caernarfon – contract with Lite company Prestatyn - (population of 19,000 / 6 wards / 18 councillors / Precept 2023-24 of £497,299) contract with Lite - expenditure on Christmas lights 2023-24 = £25,000.

The Clerk had passed on information about mega-electical.co.uk (based in Mold) and Festive Lighting Company for comparison.

It was noted that Christmas arrangements in the past used to be undertaken by Ffrindiau Port and Caru Port and the Town Council met the costs. The responsibility of organising and coordinating activities / entertainment/ guests / Christmas illuminations / electricians / Christmas trees / contractors now falls on the shoulders of the Town Council Clerk.

Decision :- The Clerk to ask Dolgellau Town Council about the price of their Christmas tree; arrange 3 quotations to be received within the month (current provider included) for a 3 year Christmas lights service agreement as proposed by Cllr Carol Hayes, Cllr Glenda Murray seconding.
