Storm Darragh - the ridge tiles of the Borth y Gest toilets have come down in the storm - the Clerk has arranged for them to be repaired.

Welsh Flags - a supply of 100 flags have arrived ready to be installed by March 1st.

Harbour 200 - the Clerk has sent advance warning to the Wylan about a public meeting in February. **Premier Inn** - it was heard that the manager of Premier Inn Porthmadog was not aware of any plans to place information boards in front of the building. Premier Inn's central office is responsible for this. **Crazy Golf** - the Clerk attended the Teams meeting with Tony Jones (Wavehill); Steve Edwards (YGC); Hannah Joyce C.G. to assess the success of Golff Giamocs. It was heard that it was profitable and perhaps considering opening it for a longer period this year.

Madocks information board - Cllr Carol Hayes was thanked for her work collating information about Madocks to share with Ffion Gwyn. For further discussion at the Finance and Property committee meeting on 28.1.25.

One Voice Wales survey - this was shared earlier today. The Clerk has already filled in the questionnaire.

The Chairman added his congratulations to **Ysgol y Gorlan** for winning the S4C Christmas Carol competition with a carol composed by Rhys and Annest Glyn. He also thanked Damian Williams for including Porthmadog in the **Tractors Tour** on 15.12.24. The trip managed to raise almost £6,000 towards the DPJ fund and the Air Ambulance. It was decided to send a word to congratulate them all.

(a) Rhif Cais / Application No.: C24/1062/44/DT (ebostio 16.12.24)

Lleoliad / Location: Pennant, 10 Stryd Ralph, Borth Y Gest, Porthmadog, Gwynedd, LL49 9UA Bwriad / Proposal: Renovation of a mid-terrace 4 bedroom dwelling to create a rear two-story extension and loft conversion that creates an open-plan kitchen and ground floor bedroom, firstfloor living room with balcony, and primary bedroom with en-suite walk-in wardrobe and balcony in loft conversion.

Decision :- to oppose the application due to the following reasons:-

- It is an overdevelopment
- It sets a precedent for similar applications
- It changes the character of the house and the area
- It would be visible from the other end of the bay
- It looks out over neighbouring properties
- It would cause noise pollution
- The additional cars of visitors staying there would cause parking problems for local residents

Advance notice of a public meeting has already been sent to be published in Yr Wylan in January and it is intended to give the date, location and time in the February issue. Wednesday evening, March 5th has been earmarked as a possible date.
